TERMS AND CONDITIONS – CANADA

1. I am of the legal age of majority in the Province or Territory in which I reside.
2. I will become an MXI Canada ULC (hereafter referred to as “the Company”) Associate upon acceptance of this Application by the Company, and I will, at that time, have the right to purchase products at wholesale directly from the Company. This Agreement becomes effective on the date received, signed by the Applicant and accepted by the Company in its main office.
3. I understand that no purchase is necessary to become an MXI Canada ULC Associate other than a \$35 Enrollment Fee. A \$25 Annual Renewal Fee is required to maintain a Distributorship. I am responsible for renewing my Distributorship each year.
4. The \$35.00 Distributorship Fee is non-refundable. Renewal Fees are also non-refundable.
5. If I wish to terminate this Agreement, I will deliver to the Company written notification of my intent to terminate. My voluntary termination will be effective as of the date such notice is received by the Company. An Associate may resign at any time for any reason.
6. As an Associate I am an independent contractor and am not an employee, partner, agent, franchisee or legal representative of the Company. I agree that I am solely responsible for my compliance with any and all laws or regulations related to my status in any jurisdiction exercising authority over me, including but not limited to compliance with applicable regulations and the Policies and Procedures published by the Company. I further agree that I shall not be entitled to receive from MXI Canada LLC any employee benefits whatsoever and MXI Canada LLC shall not be required to make contributions for Employment Insurance, Canada Pension, Workers Compensation and other similar levies in respect of payments to be made to me as an Associate. I shall be fully responsible for paying all applicable federal or provincial withholding taxes, source deductions, taxes, Employment Insurance premiums, Canada Pension Plan contributions, Workers Compensation contributions or provincial employee health tax contributions and other premiums, licence requirements and fees relating to my activities as an Associate.
7. Although the Company or any of its affiliated entities may assist me in becoming aware of applicable laws, rules and requirements, the sole responsibility to conduct my Distributorship lawfully in any jurisdiction rests with me. Therefore, I release the Company and any of its affiliated entities and their officers, directors, agents and employees from all liability for any of my conduct, actions or omissions; I also waive any claims or causes of action which I (or others acting in my interest) may have occasion to assert respecting my status or conduct as a Associate of the Company, arising out of any of my acts or omissions.
8. I understand that only Associates in good standing (as such status is determined solely by the Company) may act as Sponsors. The Company, in its sole discretion, may reject this Agreement, without disclosing any reason therefore. If this Agreement is not accepted or approved, I release the Company and its officers, directors, agents, advisors and employees from any and all liability incurred by me or by any other person. I waive any associated claim(s) that might be asserted in my interest.
9. I understand that compensation from the Company is established for my Distributorship in the MXI Canada LLC Compensation Plan, provided I maintain a Distributorship that operates in compliance with Company Rules & Regulations and Policies & Procedures, and the terms and conditions stated herein. I hereby acknowledge that I have access to the Rules & Regulations and Policies & Procedures, the contents of which are incorporated herein by reference. The Compensation Plan and its commissions, overrides and/or bonuses, relating to the sales or other output derived from personal sales, solicitations or orders from consumers, are privileges of my status as an active Associate in good standing. I agree to abide by the Rules & Regulations and Policies & Procedures established by MXI Canada LLC, and as modified from time to time and posted at www.mxicorp.com.
10. I understand that as an MXI Canada LLC Associate, I am authorized to sell MXI Canada LLC Products. I agree that I may not alter, repackage, re-label, affix additional labels of information or otherwise change any MXI Canada LLC product, nor will I sell any such product under any other name.
11. I understand and agree that I may not convey, assign or otherwise transfer any rights arising hereunder without the prior express written consent of the Company. I understand that MXI may assign, in whole or in part, any right under this agreement without notice or consent.
12. I agree that I may not create or hold a beneficial interest in additional MXI Canada LLC Distributorship(s) beyond the indirect benefits that are derived from sponsoring and downline volume.
13. In the event I choose to purchase MXI Canada LLC products on my credit card or banking debit card, my signature on this Agreement hereby constitutes my authorization to process any order I place to those accounts, and to use this as my “signature on file.” I understand that any cancellation of an order placed by me must be made within 30 business days of the placement of that particular order. Distributors may return business aids or inventory which they have purchased from the Company within the previous 30-day period without triggering an automatic termination of their distributorships. Product and business aids returned within 30 days of the placement of an order must be in resalable condition, and will be repurchased at 90% of the distributor’s original purchase price, less any appropriate setoffs and legal claims. In the case of voluntary or involuntary termination of the business relationship with the Company (or non-renewal of the distributorship), the Company will continue to allow distributors to return inventory or business aids within 30 business days of the placement of an order under the same conditions as outlined above.
14. Other than this Agreement, no other promises, representations, guarantees, or agreements of any kind shall be valid unless in writing and signed by both me and an authorized officer of MXI Canada LLC. If any provision of this Agreement is found to be unenforceable or invalid, the validity of the remaining provisions shall not be affected.
15. These Terms and Conditions are reasonably related to the State of Nevada, are made in and will be governed by and construed in all respects according to the laws of the State of Nevada, and are binding on the successors and assignments of both parties. Any controversy, claim, or lawsuit arising out of this Agreement whether during or after its term will be settled by a state or federal court of general jurisdiction located in Washoe County, Nevada. If it is found that any portion or portions of these Terms and Conditions violate any particular laws of any government or governmental unit, division or subdivision held to be applicable to these Terms and Conditions and that said violation would cause said authorities to consider these Terms and Conditions as void and without effect, then within that political unit, division or subdivision, such portion or portions of these Terms and Conditions will be of no force and effect and either these Terms and Conditions will be treated in any such jurisdiction as if such portion or portions had not been inserted herein or the court shall limit or reform such portion or portions so as to avoid any violation while preserving to the extent possible the intent of the parties. Each party having a concern shall first give notice of the offense and allow time to cure.
16. I certify the accuracy of all information provided by me in this Agreement and agree that the providing of false or misleading information authorizes the Company, at its election, to declare this Agreement void from its inception.
17. The Company agrees to manufacture quality products which it will make available under the terms and conditions of the MXI Canada LLC Rules & Regulations and Policies & Procedures.
18. I understand that commission benefits of my purchases and personal volume (PV) go to the sponsor/placement listed on this form and other MXI Canada LLC Associates under the rules of the MXI Canada LLC Compensation Plan, as published in the Rules & Regulations and Policies & Procedures.
19. Associates have an obligation to inform new Associates that the only requirement to become an Associate is the purchase of the “at cost” training kit and that purchase of Activation Orders or participation in Autoship is entirely optional.
20. I have carefully read and agree to comply with MXI’s policies and procedures, rules and regulations and MXI’s compensation plan. I understand that these terms and conditions, the policies and procedures, the compensation plan and the rules and regulations may be amended from time to time, and I agree that any such amendment will apply to me. The continuation of my independent business or my acceptance of bonuses or other benefits shall constitute my acceptance of any and all amendments. 21. I may be required from time to time to provide MXI with information relating to my sales activities. I hereby authorize and consent to the collection, use and disclosure of personal information about me relating such activities.
22. MXI Canada LLC may terminate any Associate for violation of the Rules and Regulations ten days after giving written notice, if the Associate fails to remedy the violation to the satisfaction of MXI Canada LLC within the ten-day period. An Associate may be terminated after a second violation upon written notice.
23. If any provision of this agreement is held to be invalid or unenforceable, such provision shall be amended only to the extent necessary to make it enforceable and the balance of the agreement will remain in full force and effect.
24. Any waiver by MXI of any breach of this agreement must be in writing and signed by an authorized officer of MXI. Waiver by MXI of any breach of this agreement by me shall not operate or be construed as a waiver of any subsequent breach.
25. I authorize MXI to use my name, photograph, personal story and/or likeness in advertising or promotional materials and waive all claims for remuneration for such use.
26. I certify that 1) the amount of the order on the reverse side represents my reasonably expected requirements for the retail sales and personal consumption, 2) I am not stocking unsold MXI Canada LLC products for the purpose of qualifying for bonuses, and 3) at least 70% of my previous purchases resulted in retail sales.
